SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:
 Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation.
 Wear OSHA Standard goggles or face shield. Consult Safety Equipment Supplier. Wear

- 7.2 CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES:
 Prevent material from coming in contact with common metals, particularly with carbon steel, aluminum, carbon, brasses. Prevent contact with nylon. Isolate from strong oxidants. Do not store above 49 C/120 F. Keep container tightly closed & upright when not in use to prevent leakage.
